Please inform about the question, the structure, the method and the results of the reviewed **monograph**. When reviewing **edited volumes**, it is not compellingly necessary to mention all contributions. Important is the discussion of the value of the volume as a whole for the historical study of East Central Europe. Please highlight the positive and negative characteristics of the reviewed volume and explain to what extent it achieves an innovative contribution to the historical research on East Central Europe.

Reviews that are **significantly longer than the agreed number of characters** will be returned to the reviewer for shortening. Please submit your review in .docx or .rtf format, **avoiding the use of any hyphenation, indentations or styles**. Please use **American English spelling and grammar**.

Please use the following **abbreviations**: editor = ed.; century = c. Indicate the **surnames** of (contributing) authors spaced 1.4 points upon their first mentioning. Thereafter, surnames are to be reduced to their first initial. Please use **footnotes** sparingly; cite the work reviewed using quotation marks followed by the page number in parentheses. Please include at the end of the review your **name** and **institutional affiliation**.

Please provide **bibliographic information** based on the following examples:
